

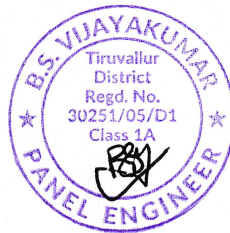

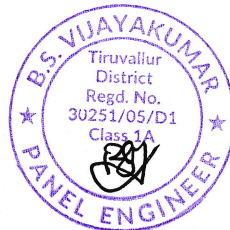

Roof Building** constructed in the years **2016 & 2019.**

This certificate covers the above mentioned buildings only and does not cover any other buildings or structures such as thatched sheds, semi / non permanant structures, compound wall, etc. This certificate does not cover any building partly completed / building under construction. 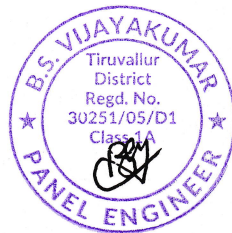

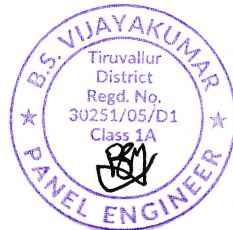
